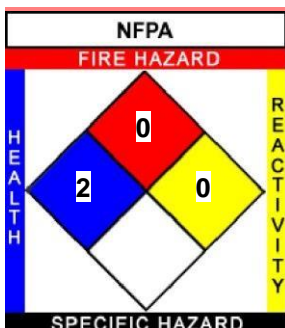

### 4 FIRST AID MEASURES

### 7 HANDLING AND STORAGE

#### Handling Precautions:
